About This Scorecard

Cornerstone's 2016 legislative scorecard selects seven roll call votes in the New Hampshire Senate and 15 roll call votes in the House from the 2015-2016 legislative session. Each vote is weighted equally. The Raw scores are not adjusted for attendance. Thus, a legislator's score will reflect the actual percentage of his or her votes that were aligned with Cornerstone's agenda and also reflect his or her attendance record. The Overall scores do not penalize for attendance. Only state senators and representatives who are seeking reelection are scored in this document.

To help supporters judge candidates based on the issues that matter to them most, Cornerstone's scorecard also arranges each of the NH House votes selected into two categories and provides a category grade for each incumbent.
