2006 Review of Senate Bills

1. Embryonic Stem Cell Research

Sponsored by Senator Iris Estabrook District 21, Senate Concurrent Resolution SCR 6 urges the U.S. Congress to support embryonic stem cell research. The Senate had three votes regarding this Concurrent Resolution.

SCR 6 VOTE #36 Amendment proposed by Senator Peter Bragdon, District 11, to change the concurrent resolution to read "*This senate concurrent resolution urges Congress to support stem cell research.*"

Passed (14 yeas – 10 nays) 3/16/2006

CPR-Action supported the amended SCR

2. Stem Cell Research

SCR 6 Vote #37 Senator Sylvia Larson, District 15, moved to have SCR 6 Laid on the Table. This is a strategic move.

Failed (11 yeas – 13 nays) 3/16/2006

CPR-Action opposed the motion

3. Embryonic Stem Cell Research

SCR 6 Vote #133 In the House Representative Kris Roberts, Cheshire District 3, amended the Concurrent Resolution to read "*This senate concurrent resolution urges Congress to support embryonic stem cell research.*" Upon return to the Senate, Senator Andre Martel, District 18 made a motion for NON-Concurrence with House.

Passed (13 yeas – 10 Nays) 5/11/2006

CPR-Action supported Non-concurrence

4. *Stem Cell Research

Introduced by Representative Lee Hammond, Grafton District 11, House Joint Resolution 20 (HJR20) supports stem cell research. Motion to Lay Lay on the Table.

Passed (15 yeas – 9 Nays) 4/20/2006

CPR-Action supported the motion

5. Second Amendment Right to Defense of One's Person

Introduced by Senator Peter Bragdon, District 111, SB 318 allows a person who is in any place where he or she has a right to be to use deadly force to protect oneself. The bill was recommended Inexpedient to Legislate.

Passed (11 yeas – 12 nays) 3/9/06

CPR-Action supported this bill

Governor Lynch vetoed the bill

6. Parental Notification and Pharmacists Conscientious Objection

Sponsored by Senator Robert Letourneau, District 19, SB 343 requires parents or legal guardians to give consent before pharmacists may dispense emergency contraceptives to minors and establishes a pharmacist conscience clause which shields pharmacists refusing to fill emergency contraceptive pre-prescriptions from civil liability and disciplinary action by the pharmacy board. This bill recognizes the fundamental right of parents to oversee the health and well being of their minor daughters and the right of pharmacists to morally object to dispensing abortifacients.This bill was recommended Inexpedient to Legislate.

Passed (14 Yeas – 10 Nays) 3/16/06

CPR-Action supported this bill

7. Mandatory Personal Flotation Device for Children

Sponsored by Representative David Campbell, Hillsborough District 24, HB 1506 extends the age where children are required to wear a personal flotation device. This bill interferes with the fundamental constitutional right of parents to oversee the health, education and well being of their children. The motion before the senate was to Lay this bill On the Table.

Passed (13 yeas – 11 nays)

CPR-Action supported the motion

8. Mandatory School Attendance

Sponsored by Senator Richard Green, District 6, SB 268 raises from 16 to 18 the age for compulsory school attendance and provides a procedure for a pupil who is at least 16 years of age to obtain an attendance waiver from school. The bill also establishes a 2-year pilot program in the Manchester and Nashua school districts to increase opportunities for interested pupils in those school districts to attend vocational education programs and making an appropriation therefore. The bill interferes with the fundamental constitutional right of parents to oversee the health, education and welfare of their child. The committee recommended Ought to Pass.

Passed (17 yeas – 7 nays) 3/22/2006

CPR-Action opposed this bill

2006 Review of House Bills

1. Sex Education in Public Schools

Introduced by Representative Russ Albert, Strafford District 1, HB 39 sets forth criteria for instruction and course materials on sex education in public schools. The original bill introduced in 2005 was amended to allow parents to "opt out" their child for religious reasons.

Failed (149 yeas – 194 nays) 2/1/06

CPR-Action supported this bill

2. Personal Flotation Devices

Introduced by Representative David Campbell, Hillsborough District 24, HB 1506 extends the age where children are required to wear a personal flotation device. This bill infringes upon the fundamental constitutional right of parents to determine the health, safety and education of their children. This bill was recommended Ought to Pass.

Passed (168 yeas – 138 nays) 3/8/06

CPR-Action opposed this bill

3. Pharmacists Rights of Conscience

Introduced by Representative Bruce Hunter, Hillsborough District 7, HB 1492 grants immunity from liability to pharmacists licensed under RSA 318 who refuse to dispense an emergency contra-ceptive pill or "morning after pill." This bill was recommended Inexpedient to Legislate.

Passed (215 yeas – 106 nays) 3/9/06

CPR-Action supported this bill

4. Second Amendment Right to Defense of One's Person, Family or Others

Sponsored by Representative Harold Dickinson, Carroll District 1, HB 1354 accomplishes three acts: (1) it removes the duty to retreat in the face of an attack; (2) it presumes that an attacker or intruder intends to cause serious bodily injury and permits force, including deadly force, to be used to protect oneself, one's family, and others; and (3) it provides that a person using force authorized by law shall not be prosecuted for using such force and prohibits a perpetrator or a perpetrator's family from suing a victim for injuring or killing the perpetrator. This bill was recommended Inexpedient to Legislate.

Passed (198 yeas – 138 nays) 3/21/2006

CPR-Action supported this bill

5. Defense of Marriage – Definition of Marriage Act

Introduced by Representative Michael Balboni, this Constitutional Amendment Concurrent Resolution, CACR 34 would allow the people to vote on a Constitutional Amendment that states "only marriage between one man and one woman shall be valid in New Hampshire." This bill was recommended Inexpedient to Legislate.

Passed (207 yeas – 125 nays) 3/21/06

CPR-Action supported this concurrent resolution

6. Lacy – Connor Peterson" Bill – Unborn Victims of Violence

Introduced by Representative Kathleen Souza, Hillsborough District 11, HB 1649-FN provides that an unborn child shall be included in the definition of "another" for the purpose of first and second degree murder, manslaughter, and negligent homicide. This bill was recommended Inexpedient to Legislate.

Passed (221 yeas – 129 nays) 3/21/06

CPR-Action supported this bill

7. Pharmacist Parental Notification

Introduced by Representative Michael Balboni, Hillsborough District 21, HB 1682 requires a pharmacist to notify a child's parent or legal guardian if the pharmacist provides a child less than 16 years of age with emergency contraception. This bill was recommended Inexpedient to Legislate.

Passed (189 yeas – 118 nays) 3/9/06

CPR-Action supported this bill

8. Beginning of Life

Sponsored by Representative Barbara Hagan, Hillsborough 17, HB 1719-FN establishes human life as beginning at the moment of fertilization for the purposes of prenatal, pregnancy, and maternity services and programs. This bill was recommended Inexpedient to Legislate.

Passed (206 yeas – 80 nays) 3/21/06

CPR-Action supported this bill

9. Stem Cell Research

Introduced by Senator Iris Estabrook, District 21, SCR 6 is a Senate Concurrent Resolution amended to urge Congress to support stem cell research. The committee recommendation of Inexpedient to Legislate was based on the previous passage of HJR 20 to support stem cell research.

Passed (149 yeas – 147 nays) 4/12/06

CPR-Action supported the Concurrent Resolution

10. Embryonic Stem Cell Research

Introduced by Senator Iris Estabrook, District 21, SCR 6 is an amended Senate Concurrent Resolution urging Congress to support stem cell research. However, after a vote to reconsider, the House amended the resolution to add the specific term "embryonic." As amended SCR 6 urged the US Congress "to support embryonic stem cell research." The House moved Ought to Pass.

Passed (198 – 140) 4/19/06

CPR-Action opposed the Amended Concurrent Resolution

11. Do Not Resuscitate Orders

Introduced by Representative Hilda Sokol, Grafton District 9, HB 656 revises the laws relative to living wills and durable powers of attorney for health care. The bill primarily addressed medical decision making for those adults without capacity to make health care decisions for themselves and establishing procedures for Do Not Resuscitate Orders. This bill had many sections and was highly complicated with potential unintended or specified consequences.

Passed (168 – 165) 5/24/06

CPR-Action opposed this bill
