CPR-Action presents our vote scorecard for the First Session (2007) of the 160th General Court of the State of New Hampshire. This scorecard reports significant votes cast on a variety of issues affecting the family.

This important tool reflects how your elected officials voted on some of the most important issues affecting our families. The votes recorded here are only a few of the many hundreds of votes the members of the General Court cast in 2007. Keeping this in mind, we tried to select the most clear-cut, pro-family and anti-family votes of this session. The information was gathered from the voting records which may be viewed at http://www.gencourt.state.nh.us/ie/rollcall/rollcallsearch.asp.

The current General Court attacked the natural family at every turn. Over and over they said you were not important. They denied you the people the opportunity to vote on the definition of marriage. They repeatedly voted against your constitutional right to parent your children by repealing the Parental Notification Law, by denying school choice, and by removing your authority to determine if your child should stay in school.

CPR Action is committed to preserving, promoting and protecting your family, your faith and your freedoms in New Hampshire. We will continue to watch the legislative activities in Concord. But, we need your help. Reporting on the votes is only the beginning of the legislative process.

2007 Review of Senate Bills

1. Floor Amendment 2076 to HB184, changes the bill and adds to the Parental Notification Law of 2003, a medical emergency exception to the parental notification prior to abortion law. This amendment also affords the pregnant minor 24-hour access to a judge for waiver of notification purposes.

Sponsored by Senator Sheila Roberge District 9

Amendment failed (Yeas:9-Nay:15)

CPR Action supported the Amendment

2. **HB184 removes the constitutional rights of parents** to be notified of their child's health decision when that decision involves an abortion. The notification of parents was ruled constitutional by the U.S. Supreme Court in *Ayotte vs. Planned Parenthood of NNE*.

Sponsored by Rep. Elizabeth Hagar, R-Merrimack, District 12

Passed (Yeas:15-Nays:9) June 7, 2007

CPR Action opposes this bill

 SB77 prohibits the Department of Health and Human services from entering into a contract with Planned Parenthood Federation of America, Inc. or any organization that provides abortion services. <u>This</u> bill was recommended Inexpedient to Legislate.

Sponsored by Senator John Barnes, District 17

Recommendation passed (Yeas:17-Nays:7) Feb. 8, 2007 CPR Action opposes the recommendation

4. **HB437** permits same gender couples to enter **civil unions** and have the same rights, responsibilities, and obligations as married couples.

Sponsored by Rep. James Splaine, D-Rockingham District 16

Passed (Yeas:14-Nays:10) April 28, 2007

Governor Lynch signed the bill into law May 31, 2007

Effective date is January 1, 2008

CPR Action opposes this bill

5. **HB791** was totally amended to establish a commission to **study** the legal and social effects of permitting **same gender marriage.** This bill as amended was recommended Inexpedient to Legislate.

Sponsored by Rep. Maureen Baxley, D-Merrimack District 6

Recommendation passed (Yeas:24-Nays:0) May 31, 2007

CPR Action supports the recommendation

6. **SB18** I raises from 16 to 18 the age for **compulsory school attendance** and provides a procedure for a pupil who is at least 16 years of age to obtain an attendance waiver from school. This bill **removes the constitutional rights of parents** to be the final authority on withdrawal from school for children who are at least 16 years of age but under 18 years of age and assigns it to the school superintendent.

Sponsored by Senator Iris Estabrook, District 21

Passed (Yeas:17-Nays:7) March 15, 2007

CPR Action opposes this bill

7. **SB42 prohibits smoking** in restaurants, cocktail lounges, and certain enclosed public places. This bill takes away individual freedoms.

Sponsored by Senator David Gottesman, District 12

Passed (Yeas:17-Nays:7) Feb. 22, 2007

CPR Action opposes this bill

8. **HB802** establishes penalties for not **using** passenger restraints. This bill was recommended Inexpedient to Legislate.

Sponsored by Rep. Jennifer Brown, D-Strafford District 5 Recommendation passed (Yeas:16-Nays:8) May 31, 2007

CPR Action supports the recommendation

9. **HB286** requires the Department of Health and Human Services to develop a Medicaid waiver to **extend Medicaid allowable family planning services** to Medicaid-eligible clients. "Family Planning" is not clearly defined.

Sponsored by Rep. McLeod, Grafton District 2

Passed (Yeas:20-Nays:4) May 24, 2007

CPR-Action opposed this bill

10. HB927 relates to the specific criteria and substantive educational program that define an adequate education. It makes mandatory full day kindergarten. This bill has a huge financial impact while denying the fundamental constitutional rights of parents.

Sponsored by Rep. McLeod, Grafton District 2

Passed (Yeas:14-Nays:10) June 6, 2007

CPR Action opposed this bill

2007 Review of House Bills

1. **HB184** removes the constitutional rights of parents to be notified of their child's health decision when that decision involves an abortion. The notification of parents was ruled constitutional by the U.S. Supreme Court in *Ayotte vs. Planned Parenthood of NNE*.

Sponsored by Rep. Elizabeth Hagar, R-Merrimack, District 12 Passed (Yeas:226-Nays:130) March 7, 2007 CPR Action opposed this bill

 HB177 includes an "unborn child" in the definition of "another" for the purpose of first and second degree murder, manslaughter, and negligent homicide. Motion to lay this bill on the table.

Sponsored by Rep. Dan Dumaine, R-Rockingham District 3 Motion passed (Yeas:239-Nays:109) March 21, 2007 CPR Action opposed the motion

3. **HB655** establishes a separate offense for causing the death of, or injury to, an unborn child. This bill was recommended Inexpedient to Legislate.

Sponsored by Rep. Maureen Mooney, R-Hillsborough District 19 Recommendation Passed (Yeas:207-Nays:76) April 5, 2007 CPR Action opposed the recommendation

4. HB612 establishes a class A felony if a person uses or threatens the use of physical force against a pregnant minor under 18 years of age in order to force the minor to have an abortion. The bill also establishes a class B felony if a person uses coercion to induce such a minor to have an abortion against her will. This bill was recommended Inexpedient to Legislate.

Sponsored by Rep. Dan Dumaine, R-Rockingham District 3 Recommendation Passed (Yeas:268-Nays:99) April 4, 2007 CPR Action opposes the recommendation

5. **HB744** requires **informed consent before a woman procures an abortion** unless it is a medical emergency. The bill requires the Commissioner of the Department of Health and Human Services to publish printed materials relative to options available to the woman. This information shall also be available on the internet. The commissioner is granted rulemaking authority to administer this law. <u>This</u> bill was recommended Inexpedient to Legislate.

Sponsored by Rep. Dan Dumaine, R-Rockingham District 3 Recommendation passed (Yeas:276-Nays:88) April 4, 2007 CPR Action opposed this recommendation

CACR1 (Constitutional Amendment Concurrent Resolution) provides that only marriage between one man and one woman shall be valid in New Hampshire. The passage of the CACR would allow the people to vote on the definition of marriage on the November 2008 General Ballot. This bill was recommended Inexpedient to Legislate.

Sponsored by Rep. Dan Dumaine, R-Rockingham District 3 Recommendation passed (Yeas:233-Nays:124) March 28, 2007 CPR Action opposed this recommendation 7. **HB235** provides that any **marriage legally contracted outside of this state** and valid in the jurisdiction where contracted shall be recognized as valid in this state. This bill was recommitted to the Judiciary Committee.

Sponsored by Rep. Marlene DeChane, D-Strafford District 3 Failed (Yeas:169-Nays:171) March 28, 2007 CPR Action opposed this bill

8. **HB437** permits same gender couples to enter **civil unions** and have the same rights, responsibilities, and obligations as married couples. Effective date is January 1, 2008.

Sponsored by Rep. James Splaine, D-Rockingham District 16 Passed (Yeas:243-Nays:129) April 4, 2007 Governor Lynch signed the bill into law CPR Action opposed this bill

9. HB791 (original verision) removes the marriage prohibition for same gender couples and makes references to marriage and terms associated with marriage gender neutral. The bill also establishes that no religious official shall be required to solemnize any marriage in violation of his or her constitutional right to free exercise of religion but does not exempt the free expression of speech by religious officials ("Hate Crimes").

This bill was amended to establish a commission to study the legal and social effects of permitting same gender marriage.

Sponsored by Rep. Maureen Baxley, D-Merrimack District 6 Passed as amended (Yeas:210-Nays:160) April 4, 2007 CPR Action opposed both versions of this bill

 HB51 permits 2 unmarried adults in a familial relationship to adopt jointly. Establishes adoption by same-sex couples.

Sponsored by Pricilla Lockwood, R-Merrimack District 6 Passed (Yeas:234-Nays:127) March 21, 2007 CPR Action opposed this bill

- 11. HB693 establishes a school choice certificate program which makes available a certain number of school choice certificates to be used at participating nonpublic schools. This bill was recommended Inexpedient to Legislate.
 Sponsored by Rep. Howard Lund, R-Rockingham District 5 Recommendation passed (Yeas:238-Nays:109) March 6, 2007 CPR Action opposed the recommendation
- 12. **SB18 I** raises from 16 to 18 the age for compulsory school attendance and provides a procedure for a pupil who is at least 16 years of age to obtain an attendance waiver from school. This bill **removes parental rights.** The final decision on withdrawal from school for children who are at least 16 years of age but under 18 years of age is removed **from parents and assigned to the superintendent**

Sponsored by Senator Iris Estabrook, District 21 Passed (Yeas:201-Nays:156) June 6, 2007 CPR Action opposed this bill
